about to enter into the Holy Bond of Matrimony with one Margaret Wells Craig of the County of Crange & State aforesaid, who is propered in her own right of certain Negroes property to wit,----Milley Negroe Girl aged Thirty-three Gilbert aged fourteen Thomas aged twelve

On Witness whereof I have hereunto set my hand and seal this the 6th day of December, A.D. 1854.

### BROWSING CORNER

Early in December, Betty Hughson and I spent a wonderful day browsing in the Orange County Courthouse. Under the guidance of Nr. Joseph E. Aebischer, Chief Deputy Office of County Comptroller and Nrs. Shackleford, we had the opportunity to learn just what the Courthouse offers us for Genealogical research.

Mrs. Shackleford showed us the oldest book of records for Orange County-Deed Book D which dates back to 1842. This book would have been destroyed in the Courthouse fire of 1868 except that the Clerk at that time happened to have it at home working on it. What a gem it was! Later, she introduced us to Mr. Aebischer who gave us the Grand Tour of the premises.

Mr. Aebischer told us that the Orange County Courthouse has the most highly sophisticated method of indexing and at the same time, the most simple method of indexing of any County system. In the Vaults, he pointed out to us such interesting records as the Soldiers and Sailors Discharge Paper (instituted after the Civil War), Immigration Records-1904-1906; 1906-1928, numerous records on Seminole County that were in the Original Mosquito County, the 1893 Tax Records and so very much more. The Platt Records. back to 1884 and even before are housed downstairs. The originals include Seminole County. All of these are public records and are at your disposal when you have time to use them.

The Society is looking for members who would be interested in copying courthouse records so if you feel this would be a contribution you would like to make, do contact your President, Betty Hughson.

### BILLY'S ISLAND: ANOTHER LOST SETTLEMENT

Until shortly after the turn of the century, on the south side of the Okefenokee Swamp, at the headwaters of the Suvannee River, there was a bustling community of Indians and White men living in harmony on Billy's Island. This beautiful but lawless Island was named for Billy Bowlegs, the chieftain of the Swamp Indians.

The population of this settlement fluctuated from 300-to- 500, and was supported by the logging industry. A railroad went through the swamp so that the Cypress Logs could be shipped to Hubbards Mill, north of Waycross, Georgia.

Billy's Island boasted of a General Store, a Theatre, a Hotel and a Railroad Station. Thrift and Fulford were well-known family names on the Island.

In 1937, the government bought most of the Okefenokee Swamp and 293,826 acres in Georgia were set aside as a wildlife refuge. By this time, the logging industry had played out on Billy's Island anyway, and the area returned to the wilds. Today a visitor can find only remmants of the dual civilizations -- an occasional chimney standing alone, a few foundations of homes and Indian mounds.

### AN UNPUBLISHED WILL

The following will was loaned to this Newsletter by Lorene Rentz Cameron (Mrs. Chester Madison Cameron) of Baytree Road, Valdosta, Georgia.

### CATHERINE RENTZ WILL

Following is the will of Catherne Rentz, widow of George Rentz mother of Simon Rentz. In the name of God, Amen, I Catherine (Caterneher-German) Rentz, widow of George Rentz and executrix to the estate of the said George Rentz of Colleton Co in the state of S.C., being very sick and weak in body but of perfect mind and memory, thanks be given unto God, calling unto mind the mortality of my body, do make and ordain this my last will and testament. Hanner following, I recommend my soul into the hands of Almighty God that gave it and my body, I recommend to the earth to be buried in a decent Christian burial at the discretion of my executors, and as touching such worldly estate wherewith it has pleased God to bless me in this life, I give, devise, and dispose of the same in the following manner and form: I bequeath to my Grandson (George Rentz) 15 acres of land whereon I now live. bequeath to Peter and Simon Rentz, (my sons) 200 acres of land, being on the Savannah Creek, to be equally divided between the 2 likewise. I bequeath to my Grandson (George Rentz) and my sons, (Peter and Simon Rentz) and my two daughters (Catherine (Rentz) Platt) and (Christine (Rentz) Fender) the remainder of my whole estate and all my household goods, and except to Catherina Smith 1 Heifer and for all the rest to be equally divided between my grandson and my two sons & my two daughters. Likewise I constitute, make, and ordain Captain William McKinzie and Jacob Platts the sole executors of my last will and testament and I do hereby utterly disallow and revoke all former testaments, wills, legacies, and executors, ratifying and confirming this and no other to be my last will and testament. I witness whereof I have here unto set my hand and seal, this 13th day of June 1785.

### ANOTHER RENTZ WILL

Will of Simon Rentz Born 1755 Died 1820

State of S.C.-Barnwell District In the name of God, Amen. I, Simon Rentz of the State and Dist aforesaid being very sick and weak of body, but of perfect mind and memory, calling to mind the mortality of my body, and knowing it is appointed for all men once to die, do make and ordain this my last will and testament, that is to say principally and first of all, I give and recommend my soul into the hands of Almighty God that gave it, and my body I recommend to the earth to be buried in a decent manner at the discretion of my executors, hereafter named, nothing doubting, but at the general resurrection, I shall receive the same again by the Might Power of God; as touching such worldly estate wherewith it pleased God to bless me within this life, I give, devise, and dispose, of the same in the following manner and form: I will and bequeath to Mary, my dearly beloved wife, one negro named Mary, with her son, Harry, with all my household furniture and plantation tools with two horses (Trummer and Blueskin), with three cows and calves, during her natural life, and at her death to be carefully kept together until my son Charles Frederick shall arrive at 21 years of age, then be equally divided amongst all my surviving children at the time, except my daughter (Margaret Hughes). I also will my beloved wife all my lands containing 781 acres except 50 acres, which I will, and desire that my son, (George Rentz), shall transfer by deed of conveyance to my daughter (Margaret Hughes), I will and bequeath that the remaining part of my estate, consisting of cattle, horses, critters, hogs, sheep, be equally divided among my children, George, Olive, Samuel, Molcy, Anna, Susanna, Kezia, Stephen, Peter, Charles, Frederick, Margaret. I do hereby constitute and ordain George Rentz, my beloved son, to be the sole executor of this my last will and testament, and I do hereby utterly disallow, revoke and disannul all other former wills, legacies and bequest by me in anywise made heretofore. In testimony whereof I have set my hand and seal this 3rd. day of April, 1815.

Information furnished by Mr. Benjamin F. Moody, Jr. (born July 8, 1856) on April 4, 1937:-

My father, BENJAMIN MOODY, SR., was born at St. Mary's, Ga. His mother was Sarah Lee from Virginia. She had a brother named Wiley Lee. Benjamin Moody's father died either just before or soon after he was born and Benjamin was reared by his Uncle Wiley Lee.

BENJAMIN MOODY, SR. came from St. Mary's, Camden Co., Ga., to Hamilton Co., Fla. and thence to Hillsborough Co. in about 1848. Farther back than that, I know nothing of my father's family.

My father, BENJAMIN MOODY, was first married in Hillsborough Co., Fla. on Feb. 7, 1833 to NANCY HOOKER, and by her had a large family of children. She died Sept. 26, 1845, and in 1854 he was married to MRS. LYDIA HENDRY (nee Carlton) who was my mother, I being

an only child of this marriage. My father was born April 15, 1811 and died Oct. 13, 1896 in his 87th year. My mother, Lydia (Carlton) Moody, was born April 4, 1812 and was, also, in her 87th year at the time of her death. She and my Father lie buried side by side in the Homeland cemetery in Polk County, Florida.

My father was one of the oldest pioneer settlers in South Florida, and fought against Osceola, Coacoochee and other famous Seminole warriors, from 1835 to 1842.

## Tombstone Inscriptions

Cemetery located at rear of Register farm in Seville, Fla. Volusia County. This cemetery may be reached by Hwy 17 to 305, the farm is about 3 miles east of Seville on 305. This cemetery had become over grown, but at the time of my visit there the timber had recently been cut so some of the markers could have been distroyed. The area was a square about one half acre in size. The three remaining markers were located near the center, but not close together.

#### RESEARCH: THE NATIONAL ARCHIVES and THE LIBRARY OF CONGRESS

At the November meeting, Norma Richardson gave the Society an interesting and informative talk on Research in The National Archives and The Library of Congress. She once lived in the Washington area and has first hand knowledge of how to use these institutions.

> ARCHIVES (Located between 7th and 9th streets)

Research at the Archives requires a Researcher Identification card which may be obtained from the main desk of the second floor central research room. This

card is valid for one year.

Some material, such as the original census books, is immediately available but many records must be requested. Military records, especially, may take several days for the librarians to gather so it is best if the researcher does not assume that he will be able to see all the

recreated original documents within a day.

The microfilm and the readers are on the fourth floor. A researcher identification card is necessary for use of this large room where Census files, Revolutionary Pension Application files, logs from U. S. Embassies and many old

books and records are housed.

Many times there are documents or records not available to the researcher because they are in the process of being microfilmed. A wise reseacher would write for verification of available materials before visiting the Archives. For information other than military records, pensions or Bounty Land Warrants, one should write to :

### ARCHIVES AND LIBRARY OF CONGRESS RESEARCH con't.

GSA Form 6751 is used for Pension Records, Bounty Land Warrant Applications, or Military records. The researcher is expected to supply the veteran's name, State from which he served, war in which he served or the dates he served—if Civil War Records are requested, then the researcher must specify Union or Confederacy. The researcher should expect a bill for this service when the records are received. The "Index of Revolutionary War Pension Applications" available in the Orlando Public Library will assist the reseacher.

THE LIBRARY OF CONGRESS
(Located behind the Capitol; Genealogical Room located in the Thomas Jefferson Room in the Library Annex directly behind the main Library)

In this area, a last-name index card ffile is available. Books mentioned in the file may be ordered by turning in the proper order form to the main desk. Books are delivered to the numbered desk of the reseacher. Special passes for browsing through the stacks can also be obtained from the main desk.

DID YOU KNOW! The microfilmed safety copies of the Official Records of Orange County are stored in the National Underground Storage Corp. vaults at Boyers, Pennsylvania. The storage premises, in which some 200 people are employed, consist of an extensive complex of underground passages remaining from a U.S. Steel Corporation limestone mining operation terminated in 1957. Some 154 major corporations and governmental entities, including the General Services Administration, rent space. Each space varies in size and is properly secured by Mosler vault doors. Proper film storage temperature and humidity is a natural feature of the premises. The entire complex is under tight security utilizing armed guards and an identification badge system.
